- **Manual on Uniform Transportation Control Devices (MUTCD) 11th Edition Changes & Why Should We Care - with special reference to Central Ave**
 - The Federal Highway Administration has a short video introducing what the MUTCD is and what some of the updates concern:

 - Ed discussed how the old section 2B.13 regarding speed limits emphasized the 85th percentile rule by which **“When a speed limit within a speed zone is posted, it should be within 5 mph of the 85th -percentile speed of free flowing traffic”** and how this rule has been relied on by our State DOT to limit reductions in speed limits.
 - Ed quoted a section from the 2015 DOT Report on Central Avenue (State Route 5) in Colonie and how the 85th percentile rule was used to justify leaving the speed limit on that persistently deadly corridor at 40 mph.
 - The 11th edition section 2B.21 de-emphasizes reliance on the 85th Percentile rule, particularly on urban and suburban non-freeway arterials. **“When setting a speed limit, a range of factors such as land-use context, pedestrian and bicyclist activity, crash history, intersection spacing, driveway density, roadway geometry, roadside conditions, roadway functional classification, traffic volume, and observed speeds can influence the speed limit determined in the engineering**

study. The engineering study will determine which of the recommended factors will prevail in setting the speed limit."

- The new MUCTD 2B.21 also notes, "**To achieve desired operating speeds, agencies often implement other speed management strategies concurrently with setting speed limits, such as traffic calming measures, geometric design features, speed safety cameras, and increased enforcement.**"
- Ed reminded us that road studies on the Colonie section of Central Avenue west of Rt 155 to Niskayuna and the Albany City section of Central Avenue are due to take place in 2024 and that we will need to show up and work to see that they deliver safer roadways.
- John Gillivan said he would check on the status of the Colonie study and also said he was working with others in the Village of Colonie on a "Slowdown Campaign" and has himself reached out to engineers in our DOT region.

- **Other Central Avenue Efforts**
 - The Albany Times Union published Ed Brennan's Commentary "[There Are No Accidents on Central Avenue](#)" on 12/3/23
 - Our next Ride of Silence scheduled for Wednesday May 15, 2024 - will be returning to Central Avenue. We hope to get media and public attention focused on the need to improve safety there and inspire people to get involved in the Central Avenue road studies.
 - We are working on getting a ghost bike installed where cyclist Joe Crandall was recently killed on Central near Elmwood in Colonie
- **NYS Safe Streets Coalition Update** Ed reported our statewide coalition (NYSSSC) has its slate of bills online with a link that will let you generate a message to your State Senate and Assembly Member to support the bills.

 - The NYSSSC is also pressing NYS DOT to update their policy on last year's 25 mph legislation. A letter was signed by over 100 elected representatives and stakeholders from all around NY. The current policy requires onerous, time consuming and expensive engineering studies by municipalities that may just wish to lower their speeds by just 5 mph for public safety.

- **Albany City Ordinance Proposals**
 - On the agenda of the Jan 4th Albany Common Council Meeting: Mr. Hoey has introduced a resolution to ask NYS DOT to help and not hinder municipalities that want to reduce their “area” speeds to 25 mph under the law signed by Governor Hochul last year
 - Specifically, the resolution states “the Common Council of Albany, New York calls on NYSDOT to reevaluate this regressive policy which skews the intent of this important legislation and dilutes its life saving potential”
- **Albany DGS Comments of Frank Zeoli.** Ed reported that our Albany City Deputy Commissioner of DGS addressed his Normans Kill Neighborhood Association in early December.
 - Mr. Zeoli explained that the City’s road repaving schedule was determined each year based on a number of factors, including
 - Road Conditions, based on their observations
 - Equity, to make sure all Albany’s neighborhoods received fair attention and also social equity based on historic neglect of underserved communities.
 - Mr. Zeoli also commented on the planned merger of Traffic Engineering & Road Planning functions. He noted that the actual work would still be done by DGS and those planning the work would still reside for now in DGS quarters, though the chain of command might be changing.

- **Cherry Avenue Extension Meeting Report** - Peter, John V., Lorenz and Ed joined over 50 attendees meeting at the Bethlehem Town Hall. Peter reported:
 - The contractor revealed their current plan to establish trails along Route 85 in Slingerlands connecting the Rail Trail to the traffic circle at the intersection of Route 85 and New Scotland Avenue.
 - The monies are allocated, the project will be happening

- Future connections along New Scotland Avenue to the Normans Kill boat launch and along Blessing Road were also mentioned by the Town Supervisor.
- We had a brief discussion of the pros and cons of “bike box” planned to facilitate cyclists turning left from Cherry Ave Extension onto the new bike trail entrance at Kenwood
- Peter recommended submitting comments to promote a connection to the Pine Hollow Arboretum

- **County Rail Trail / SE Connector Updates -**
 - Mark noted there is a fair amount of glass, gravel mud and debris on the South End Connector along 787. He didn't think DGS has been cleaning it for at least a week. Hugh said he would get in touch with DGS.
 - Peter noted the County has added cones and more fill to address the part of the trail experiencing subsidence.
- **Albany High School Area Traffic Calming** - Chester was not able to attend our meeting but has continued to work with the PTSA to try to address safety concerns around the High School and throughout the length of Washington Ave.
