

## **Albany Bicycle Coalition Meeting Notes for April 25, 2024**

### **Special Topic - Addressing Mayhem on our Roadways**

- **Albany City Ordinance Proposals**

- Proposal for **Albany Pedestrian and Cycling Advisory Commission** - Council Person Deborah Zamer and Zvi Gomez Fisher joined us to discuss this potential Albany City Law. It is the brainchild of Zvi, a bright Albany High School Student serving as an intern with the City Council. The Commission would:
  - have 5 Albany City resident volunteers appointed by the Mayor and City Council
  - Include at least one resident with a child in a City school
  - Have members that engage in or advocate for active transportation
  - Be as diverse as possible
  - Include non-voting “ex-officio” members of relevant City departments and the Sustainability Advisory Committee
  - Determine City areas that were unsafe for vulnerable road users
  - Study what should be done to correct safety deficiencies
  - Recommend changes to responsible departments, which would need to respond within six weeks
  - Review implementation of the City’s Bicycle and Pedestrian Master Plan and produce an Annual Report
  - Help publish maps and guides for self-guided tours
  - Foster public comments and discussions
- Mr. Gomez Fisher and Council Member Zamer were receptive to thoughts and concerns brought up at our meeting and in recent online discussions. Some of the comments went into amendments that the Law Committee approved and sent on to the Common Council on May 1st. Concerns included:
  - The commission should be renamed to reflect “active transportation” (the name change was included by amendment)
  - the Commission would need access to location specific crash data this is not currently publicly accessible (they are considering how to accommodate this)
  - the proposed law does not include the City Engineer. (this was included by amendment)

- James Rath had commented, the bike-ped scope is more narrow than necessary and a more robust committee on streets and transportation, should include transit/CDTA, disability advocates, storm water issues, parking authority folks, etc. Others agreed disability and transit champions should be represented if possible, but other issues should probably be left for other departments or committees to provide commentary to the Commission - to keep the focus of the Commission manageable.
- Mr. Rath and Ms. Gonzalez both pointed out that the amount of voluntary work expected by the Commission, particularly the annual report and research, might be more than can be expected of volunteers.
- Mr. Rath noted City residents need a meaningful way to comment on the annual paving schedule, budget and long range plans.
- Mr. Rath also noted that Troy had a similar advisory committee that was routinely ignored by the City. We don't want this commission to be "a box checked" implying that the City was listening to the needs of vulnerable road users without actually doing anything.
- Jackie Gonzalez - asked that there be adequate paid staff in addition to the unpaid advisory committee, to make sure things actually get done and so the city doesn't externalize these responsibilities on volunteers.
- Ed noted there was still no response from our new City Engineer on the letter sent on behalf of ABC last month.
- City 25 mph Legislation - Council Member Zamer said she had no update from the administration on progress of the City's investigation of lowering the area speed limit. Ed reported hearing at the CRTC Active Transportation Advisory Committee meeting that the City's study had been completed. Council Member Zamer said she would investigate.
- **Safe Streets Coalition Update**
  - 1st Coalition Bill Passed - Sammy's Law which allows NYC to lower speed limits to 20mph was in the Budget Bill!

## Reports

- **Capital Streets/Walkable Albany/ABC Cooperative Effort -**
  - A Candidate Survey of Complete Streets / Bike-Ped issues was sent on behalf of the three organizations to those running for Pat Fahy's Assembly seat. (Pat Fahy is expected to win the Senate seat of Mr. Breslin)
- **Bikeatoga Update -** Ed Lindner reported they are holding "Slow Rolls" every 3rd Sunday of the month, 10am-noon from the Statute of Life in Congress Park
- **Earth Day Ride -** Everyone agreed the ride was a success. 20 riders negotiated a planned route with stops to discuss places where Complete Streets improvements were made and were still needed in the City of Albany. Afterwards, many joined for refreshments and banter at Martel's. Extra **green kudos** to those that also biked to the event!
- **Broadway Resiliency Plan Meeting** Ed reported attending a Zoom meeting on how to improve flooding and sustainability on Broadway from Clinton Ave in Albany to Watervliet. The notion of continuous bike lanes on the corridor was discussed, with the possibility of protecting the lanes with a permeable buffer of green space.

- **CRTC Active Transportation Advisory Committee Report**
  - Jen Ceponis announced she is leaving for the private sector. Her leadership on matters relating to the CDTC Trails Plan and safe travel for all users was recognized. It is hoped she inspired others at CRTC to continue her good works.
  - Feature Presentation: Regional Vision Zero Action Plan Update (by Carrie Ward)
    - Key outcomes include
      - Building partnerships and a shared vision around regional roadway safety using a 4 E's approach - engineering, education & enforcement ("emergency svcs" being the #4 E added to the traditional 3 E's)
      - Developing a comprehensive Safety Implementation Program of fundable projects and annual reporting on that program
    - Adopting a "*Safe System Approach*", which has had success in other countries. Including: adopting a vision zero target with a date.
    - Equity analysis, safety analysis (data review, historic trends, network screening, high injury network, systemic safety analysis), speed limits to enable certain municipalities to reduce speed limit to 25 mph.
    - Developing a strategy and selecting projects, safety investigations at 40 sites, and policy and process changes, a transparent progress report, and a final vision zero action plan

## Transportation Projects

- **County Rail Trail / SE Connector Updates** - Peter reported the subsidence issue west of Delmar was corrected but the work on the overpass near the bender farm is continuing and resulting in closures west of Upper Font Grove Rd.
- **Manning Boulevard Improvement Project**
  - Unfortunately, little is to be changed in final recommendation

- Recommendations for protected bike lanes on this essential North-South connecting street that were in Albany's own Bike Ped Master Plan appear to have been ignored. The paving work that will be done will likely doom this part of the plan for the next decade until the road decays enough to merit investment in another project.
- **Brevator, Washington and Western**
  - **Albany High School Area Traffic Calming** - there are rumblings that the City and the School District may cooperate on a study to address dangerous conditions by the High School.
  - **City Grant Proposals for Washington and Western**
    - Said to complete loose ends of **Brevator and Manning Projects**
    - **ABC** and others submitted letters of support for City grant proposals to address bike-ped issues on portions of Washington and Western (with the promise of these whole roadways to eventually have Complete Streets treatments).
  - **Brevator Project:**
    - Per DGS, the project is to start Spring 2024
